

## Dear Sir,

This is in connection of our earlier letter dated August 14, 2021 on the above stated subject, whereby we had informed you about the resolution passed in the Board meeting held on the said date approving the request received from various persons for re-classification of their name from the 'Promoter and Promoter Group Category' to the 'Public Category', subject to approval of the Shareholders.

In this regard we wish to submit that pursuant to the provisions of Regulation 31A (3)(a)(ii) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended vide SEBI circular dated May 05, 2021, the approval for re-classification from the Shareholders of the Company needs to be obtained within a period of not less than one (1) month and not more than three (3) months from the approval of the Board of Directors. Accordingly, the Shareholders' approval was required to be obtained by November 13, 2021.

However, the Annual General Meeting of the Company is scheduled to be held on December 21, 2021 (extension of time for holding the Annual General Meeting, having been obtained from the Registrar of Companies, NCT of Delhi & Haryana).

Hence, it was necessary to place the matter again before the Board for re-consideration. Accordingly the matter was placed before the Board at its meeting held yesterday, October 12, 2021 and the resolution was passed unanimously.

To re- consider and approve the requests received for Re-Classification of certain persons from 'Promoter and Promoter Group Category' to 'Public Category'.

The Director noted that the Board at its meeting held on August 14, 2021, approved the requests received from 13 persons belonging to the "Promoter and Promoter Group", to re-classify, their shareholding in the Company from the category of 'Promoter and Promoter Group' to the category of 'Public' shareholding and removal of their names from 'Promoter and Promoter Group' of the Company subject to the approval of Shareholders.
